When you have the allocated EYFE for 2 year olds eligibility number please provide this to the school office together with your National Insurance Number so that we can verify the funding allocation.

2 year old 15 Hours Entitlement (UK residents only) in Agreement with BHCC and is delivered between 8.45am – 12.15pm for the 38 weeks of school term per year.

A standalone space with no additional fees for 2 year old entitlement is from 8:45 – 11:45am subject to availability.

For children aged 3 – 5 years old attending 8.45am – 12.15pm, from 3 years old children are invited to attend five mornings per week (three mornings minimum).

The 15 hour Early Years Free Entitlement (EYFE – UK residents only) is available for children in the school from the term following their third birthday until the term they reach statutory school age (5 year olds), subject to eligible dates of birth notified to us by the Local Authority. A standalone space with no additional fees for both the 3 & 4 year old entitlement is from 8:45 – 11:45am subject to availability.

Children 3 – 5 years old 30 Hours Entitlement (UK residents only) in Agreement with BHCC information is available through our school office and is delivered between 8.45 – 11.45am and 12 – pm for the 38 weeks of school term per year. A standalone place with no additional fees is from 8.45am – 2.45pm subject to availability.

For children aged 5 – 12 years old the fees per term are £3,321 for 5 days 8.45am – 3pm per week.

There is a 10% discount to a sibling attending at the same time as an older child.

Terms and Conditions include:

School Fees are due termly in advance and are non-refundable once term has started. We accept payment by electronic transfer, cash or card. We also accept Employer Childcare Vouchers or Government tax free childcare scheme **(Please be aware that we can only accept childcare vouchers up until the term your child turns five years old in school)**

- One term's notice for children 5 yrs + leaving the school must be given in writing otherwise fees are due in lieu and deposits will not be refunded as per our terms and conditions.
- **One month's notice is required for those children in receipt of EYFE.**

Late payment of fees will incur a £50 administration charge for each payment reminder. Full terms and conditions are available from the office.
